SERVICE CHARGE: The service charge for different sizes of meters will be billed on either the monthly or quarterly basis in accordance with the Company's billing procedure. The Company may bill a quarterly customer on a monthly basis using one third of the quarterly service charge. These charges shall be as follows:

RATEI. EXISTING HYDRANTS

For Standard Fire Hydrants in existence on December 31, 2021 in streets, roads, or rights-of-way as ordered by the municipality, there shall be paid to the Utility by the municipality served a Fire Protection Charge as follows:

For 179 Standard Fire Hydrants \$ 43,230.48 per month in advance

For 99 Standard Fire Hydrants 23,694.72 per month in advance

For 74 Standard Fire Hydrants 15,269.96 per month in advance

SERVICES FOR MUNICIPAL PURPOSES (cont'd)III. GENERAL

All hydrants installed by the Utility for Public Fire Protection purposes will be cared for and maintained in good working order (unavoidable accidents excepted) by the Utility. Hydrants are to be connected only to mains having a diameter of 6 inches or larger.

Once any Fire Hydrants are actually installed and are in operation, the total monthly Fire Protection charge then in effect shall not be reduced should the municipality order one or more hydrants discontinued.

Should the Town order any hydrant moved to a different location, the Town shall pay all costs of moving said hydrant or hydrants.

IV. SERVICE FOR OTHER MUNICIPAL PURPOSES

All present and future buildings or water services owned or operated by the municipality or owned or operated by any present or future municipality school, sewer or other districts or any subdivision thereof, shall be metered and same shall be billed at the regular filed meter rates. Further, the regular Private Fire Protection rates, if applicable, shall apply also to the above-mentioned property. The municipality shall be bound by the applicable Terms and Conditions as filed with the Public Utilities Commission.

SPECIAL INDUSTRIAL SERVICE RATEAVAILABILITY

This schedule is applicable to any large industrial customer served directly by a main that is 16" or larger in diameter and for which the infrastructure of the water system was designed and constructed to meet the special needs of the customer's industrial facility.

RATESMonthly Billing Consumption Charge

The rates in this schedule assume that service to the industrial customer is being provided by two meters. Each meter will be billed in accordance with this schedule. If meters are reduced or eliminated the total fee will not be reduced if the water to the property is available for use as in accordance with this schedule.

In the event that the bill is not paid within 25 days from the postmarked date of the bill, the charges become subject to a late payment charge as defined on page 4 of the company's Terms and Conditions.
